<sup>1</sup>**Active Member:** Individuals, firms, or corporations regularly engaged in the wholesale, interstate, and/or international distribution of seeds for planting, excepting retailers selling seed exclusively in packets, are eligible for Active membership in the Association. To qualify for and remain an Active Member of the Association each Active Member must have a current valid wholesale seed dealer license issued by the appropriate authority as is required in the jurisdiction or jurisdictions in which they trade; and which allows them to engage in the wholesale, interstate or international distribution of seed. All Active Members must provide proof of such seed dealer license upon the request of any officer of the association, and the sufficiency of such license for Active membership is at the absolute discretion of the Board of Directors.

<sup>2</sup>**Associate Member:** Individuals, firms, or corporations in any way engaged or connected with the seed industry or its allied branches, excepting those qualifying for Active or Affiliate membership.

<sup>3</sup>**Affiliate Member:** Individuals, firms, or corporations who do not maintain an established place of business in the State of Oregon and are engaged in the distribution of seeds for planting, with the exception of retailers selling seed exclusively in packets.
