<sup>1</sup>**Active Member:** Individuals, firms, or corporations regularly engaged in the wholesale, interstate, and/or international distribution of seeds for planting, excepting retailers selling seed exclusively in packets, are eligible for Active membership in the Association. To qualify for and remain an Active Member of the Association each Active Member must have a current valid wholesale seed dealer license issued by the appropriate authority as is required in the jurisdiction or jurisdictions in which they trade; and which allows them to engage in the wholesale, interstate or international distribution of seed. All Active Members must provide proof of such seed dealer license upon the request of any officer of the association, and the sufficiency of such license for Active membership is at the absolute discretion of the Board of Directors.

<sup>2</sup>**Associate Member:** Vendors, suppliers, and companies other than those who sell or distribute seed, but who offer products or services ancillary to the seed industry, and have an interest in conducting business with member companies.

<sup>3</sup>**Affiliate Member:** Students, faculty, and other individuals associated with agriculture in an academic setting, and seed and other trade organizations who have an interest in the seed industry but are not presently engaged in the production, sale or distribution of seeds.
